BAUMAALIGHT ATTACHMENT STOCKING DEALER PROGRAM

Same as 2024, in 2025 we offer the program in two 6-month booking periods to make it easier to get in with a booking deadline in January and again in July. The new program will only apply to whole good orders and we are still working on a new parts order discount program.

To activate the Stocking Dealer Program, simply place a stock order for whole goods in the timeframe listed below.

Based on the value of your current paid stock, plus the value of the new stocking order, you will then receive the appropriate additional discount for the remainder of the 6-month booking period.

Another change we are making for 2025 is that only some dealers will be eligible for longer terms, this will be decided on a case by case bases.

- 1. Payment terms are due when the attachments are sold or on due dates specified above, whichever comes first.
- 2. The discount achieved would apply to all Baumalight whole good orders except mini skidsteers for the next booking period. Parts orders no longer get a stocking dealer discount but we are coming out with new parts order programs.
- 3. Paid inventory is eligible for minimum quantity requirements, but must be new and have been purchased within 12 months to qualify.
- Auger drives and bits are not eligible for Stock & Save minimum piece order requirements (See Auger Drive Booking Program for separate booking order discount structure for Auger Drives and parts).
- 5. Tree Scoops and Tree pullers also do not qualify as whole goods to help you qualify for this program. However, once

qualified, they will receive the discount for future orders.

- 6. Must make a new purchase, and everything must be ordered to ship in one shipment to one address.
- 7. No urgent delivery requests allowed, if you need something quick then another order must be placed.
- 8. Mini Skidsteers are on a separate program, but stocking 2 or more mini skidsteers will automatically qualify you for one of the above discounts, see complete details under mini skidsteer program
- 9. The Stock & Save discounts are only available direct to dealer, and not available through distributors. This allows us to have a lower list price which benefits everyone.
- 10. Terms will only be offerd to some dealers and will be decided on a case by case bases

AUGER DRIVE PROGRAM (ORDERS INTENDED FOR DISPLAY)

Separate from our Stock & Save Program, we also offer an Auger Bit and Drive Program. Order stock of Auger Bits & Drives between December 1, 2024 and January 28, 2025 and based on the value of your stocking orders, you will receive an additional discount on auger drives, bits, extensions, adapters and accessories ordered before December 31, 2025.




